After School Jumping & After Work Jumping

Dear participants,

We are delighted to present the “After School Jumping” and “After Work Jumping” training format to you.

Our training day is, of course, being conducted in compliance with the currently applicable Corona conditions, in order to curb the spread of the virus. The implemented measures include among others the **obligation to wear a face mask** on the grounds.

It is essential to complete and sign the attached **attendance record and hand it in to the steward on entering the grounds.**

Due to the applicable Corona regulations, we would kindly ask you to leave the grounds shortly after completing your own training.

1. Arrival

- GPS address: Hubert-Wienen Straße, 52070 Aachen
- Access to the truck car park is via Gate 19. Here you will be greeted by our stewards, who will provide you with further information. There are sufficient parking spots so that the vehicles can be parked with sufficient space in-between.
- On entering the training grounds, you will be asked to submit the “attendance record” for all persons present. Training will not be permitted if this form is not presented.
- Each person has to bring a face mask with them.





2. Accompanying persons

- Only one accompanying person is permitted per rider and horse. One further person is permitted for each further horse registered.
- Unfortunately, further accompanying persons and spectators are not permitted to enter the grounds.

- There will not be a show office on-site.

4. Warm-up area

- The current maximum number of horses per arena applies on the warm-up areas (presently 10horses per arena or 200m² per horse).
- 2 warm-up areas are available, so each participant has sufficient preparation time
- In addition to the participants, only the persons necessary for the preparation (i.e. for building the obstacles) are allowed to be on the warm-up area.
- We kindly ask the participants to leave the warm-up areas in a timely manner after the training.





5. General notes

-The training is governed by the rules of the LPO of the German National Federation (FN Handbook).

-ONLY drinks can be purchased at the grounds.

-Participation is at one's own risk. The ALRV assumes no liability for costs and damages caused by participants or their accompanying persons.

-It is not necessary to wear competition dress.

-We would kindly ask you to keep the car parks clean and to refrain from brushing the dung from the trailers.

-Dogs are not permitted anywhere on the grounds.

Corona info sheet

- ✓ Please complete and sign the “Attendance record” and hand it in on entering the grounds.
- ✓ Only one accompanying person is permitted per participant/horse. In the case of two or three horses, two accompanying persons are permitted.
- ✓ Spectators are not permitted.
- ✓ In order to reduce the number of people on the grounds, we would kindly ask you to leave the grounds in a timely manner after your training session.
- ✓ Only persons who do not show illness symptoms typical for the COVID-19 virus are allowed to enter the training grounds.
- ✓ Each person has to maintain a social distance of at least 1.5 metres from other people. However, this does not apply for people who belong to the same household as the registered person.
- ✓ The current maximum number of horses per arena applies on the warm-up areas (presently 10horses per arena or 200m² per horse). Several warm-up areas are available so that every participant has sufficient preparation time.
- ✓ In addition to the participants, only persons necessary for the preparation (i.e.for building the obstacles) are allowed on the warm-up area.
- ✓ The use of a face mask is obligatory in places where it is difficult to maintain the minimum safety distance or where particular caution is necessary.
- ✓ Of course, the general hygiene and infection protection measures pursuant to <https://www.pferd-ak-tuell.de/coronavirus> have to be observed throughout the grounds. (maintenance of social distances, thorough and frequent washing of hands, observation of the rules regarding sneezing and coughing, avoidance of touching one’s face, etc.)
- ✓ Non-observance of the requirements/notes constitutes an infringement of LPO §920, clause 2 and can result in disciplinary measures in accordance with LPO § 921.
